

# Community Action Partnership of Lake County Communication Update:

# Illinois Emergency Small Business Grants and Loans Assistance

Under the leadership of Governor JB Pritzker, DCEO is working with partners to launch more than \$90 million in emergency assistance programs for Illinois small businesses. <u>SEE DETAILS HERE.</u> These initiatives include:

#### **Hospitality Emergency Grant Program**

To help hospitality businesses make ends meet in the midst of the COVID-19 pandemic, DCEO is launching the Hospitality Emergency Grant Program with \$14 million drawn from funds originally budgeted for job training, tourism promotion, and other purposes.

# Who is eligible?

Bars and restaurants with a valid license to serve food or liquor and who generated revenues of less than \$1 million in 2019. Hotels with a valid license (hotels, motels other lodging establishments) and who generated revenues of less than \$8 million in 2019.

# How do businesses apply?

Businesses can submit an application online here: <u>Landing Page</u>, <u>English Application</u>, <u>Spanish Application</u>. Applications for awards will be accepted until 5:00pm on April 1st, and winners will be chosen via a lottery, therefore, there is no benefit to submitting an application first as long as a valid, complete application is received by the deadline.

# Illinois Small Business Emergency Loan Fund

DCEO and the Illinois Department of Financial and Professional Regulation (IDFPR) are establishing the Illinois Small Business Emergency Loan Fund to offer small businesses low interest loans of up to \$50,000.

## Who is eligible?

Small businesses located outside of the City of Chicago with fewer than 50 workers and less than \$3 million in revenue in 2019 can apply. Small businesses within the City of Chicago can apply to a similar loan program <a href="here">here</a>.

#### How do businesses apply?

Businesses will be able to complete an interest form on <u>State of Illinois DCEO web page</u> on Friday, March 27, 2020.

# **Health Department Coronavirus Update**

**Lake County, III.** — The Lake County Health Department is reporting 30 new cases and one new death from the Coronavirus Disease 2019 (COVID-19) in Lake County since Saturday. This brings the total number of Lake County residents testing positive for the disease to 294 (as of March 29, 2020, 1:45 p.m.) and the total number of deaths to 3.

The Lake County Health Department continues to remind those who attended the North Shore Christian Quad City Revival in North Chicago the week of March 15 - March 20 to please stay home if you are experiencing symptoms of COVID-19. Several people who attended this event have tested positive for COVID-19. As a reminder, having attended the event is not reason enough to be tested for COVID-19, but people who experience a worsening of symptoms should contact their healthcare provider.

"I know it seems like I have been repeating myself every day, but I can't emphasize it enough - stay home, practice social distancing on the rare occasions it becomes essential to leave, and repeatedly wash your hands," said Lake County Health Department Executive Director Mark Pfister. "People should assume COVID-19 is in every community and in every neighborhood. Close interactions with an infected person will spread the virus to yourself and others. So - again - everyone should do everything they can to slow the spread."

It is critically important that the community follow prescribed preventative measures such as social distancing and the **3 C's** to avoid getting sick:

- Clean hands often with soap and water for at least 20 seconds, or use a hand sanitizer that contains at least 60% alcohol;
- · Cover your cough and sneeze with a tissue or your elbow; and
- Contain illness by staying home if you are sick.

#### Social Distancing

- Stay home as much as possible.
- Maintain a distance of 6 feet between yourself and others.
- · Call to check on family, neighbors, and older adults instead of visiting.
- · Check with your healthcare provider about telehealth options.

the household and if possible, stay in your own bedroom and use your own bathroom. Contact your doctor if your illness is worsening (for example, you have difficulty breathing).

Do not walk into a healthcare facility, urgent care clinic, or hospital before calling. Discuss your symptoms with your doctor. If your doctor believes that you need to be tested for COVID-19, your doctor should refer you to a COVID-19 testing site. The Lake County Health Department should only be contacted by your doctor to facilitate testing through the State lab for patients who are hospitalized or those who live or work in congregate settings (e.g., schools, long term care facilities, and group homes).

Residents who do not have a primary care provider can contact the Lake County Health Department and Community Health Center at (847) 377-8800 to schedule an appointment.

#### Testing availability

Testing is being prioritized for people with symptoms who have high risk of complications. This includes older adults living in congregate settings and those with chronic health conditions like heart disease, lung disease, or diabetes, and those with weakened immune systems. People who do not show any symptoms do not need to get tested.

A number of healthcare providers in Lake County currently have tests available. The Public Health Emergency Operations Center (PHEOC) is working to collect information on the availability of testing in Lake County and will provide updates at <a href="https://www.lakecountyil.gov/coronavirus">www.lakecountyil.gov/coronavirus</a> as it becomes available.

#### **Health Department Service Modifications**

The Health Department's Community Health Centers continue to provide care for patients during this time, and modifications have been made to protect the health and safety of all patients and staff:

- Services are being provided over the phone when possible
- · Social distancing measures have been put in place in the clinics
- Non-urgent in-person visits are being rescheduled for 4-6 weeks in the future
- Women, Infants, and Children (WIC) services are provided over the phone, and WIC coupons are provided curb-side
